The legal voters of the Town of Westbrook, Connecticut and all others qualified to vote in meetings of said Town are hereby notified and warned that a Special Town Meeting will be held in the Multi Media Room of the Mulvey Municipal Center, 866 Boston Post Road, Westbrook, Connecticut on Thursday, September 16, 2021 at 7:00 p.m. to act on the following matters:

Item 1: To consider and act upon the following resolution, as recommended by the BOS and the BOF:

RESOLVED: That the Town accept and appropriate a grant from the State of Connecticut, Connecticut State Library in the amount of \$47,280.00 for the purpose of the installation of a new high-speed internet connection to the Connecticut Education Network (CEN), and hereby authorizes the First Selectman to execute such documents as may be necessary to accept said grant and receive such funds.

Item 2: To consider and act upon the following resolution, as recommended by the BOS and the BOF:

RESOLVED: That the Town accept and appropriate a grant from the State of Connecticut, Connecticut State Library ARPA funds in an amount not to exceed \$15,867.00 for the purpose of the purchase of portable/flexible seating, outdoor seating, mobile workstations and portable shelving as approved by the Library Board of Trustees, and hereby authorizes the First Selectman to execute such documents as may be necessary to accept said grant and receive such funds.
