- 4) An accurate elevation drawing of the proposed sign and the supporting structure or building façade intended to receive the sign, showing the sign dimensions, area, and height above finished grade, and proposed location of the sign in relation to the building façade and roof line.
- 5) The aggregate area of all existing signs on the lot.
- 6) The type of construction, sign supports, and any mechanical or electrical details.
